INVESTMENT MANAGER COMMENT


August produced a +0.28 % return, steadily adding to the YTD performance. The Brazilian Tree Industry (IBA) held a conference on best practice in the plantation industry. IBA promoted the establishment of plantations in 'mosaic' form interspersed between the natural forest so as to create ecological corridors. IBA reported that the adoption of innovative landscape management results in multiple benefits in terms of biodiversity sustainability, regulation of water resources and conservation of natural forests. The fund's Brazilian holdings mark an example of this strategy.
