## **INVESTMENT MANAGER COMMENT**


March performance was +0.84 %, in line with the fund's monthly target level. Performance for the full first quarter of 2015 stands at +4.74 %. The strong performance of the quarter, or excess-performance above target, is mainly due to the development of the Sterling (GBP) vs the Swedish Krona (SEK) which is the fund's base currency and with a large portion of investments denominated in GBP produces a foreign exchange profit for the fund.
